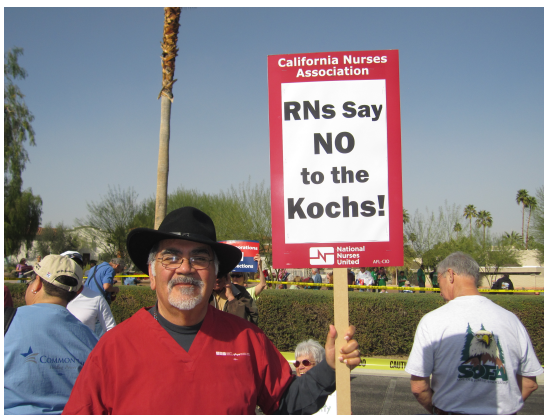


### “Uncloaking the Koch Brothers” Rally

Organized by Common Cause (and 26 supporting organizations), the rally

gathered nearly 1000 protesters outside the Rancho Mirage Resort where the Koch brothers had invited conservative leaders to discuss strategies for the upcoming two years. See website for details and more photos.



## FEBRUARY MEETING DETAILS:

### Miramar Landfill

Sherri Lightner will speak to the Miramar Landfill issue, which was discussed at the January meeting. In January the club heard from a representative of the Center for Policy Initiatives (<http://onlinecpi.org/article.php?list=type&type=384>) who outlined the reasons that the CPI is opposed.



This month we will hear Sherri Lightner's position.

Sherri Lightner is a long-term resident of San Diego, currently residing in La Jolla Shores. She was elected for a four-year city council term in November 2008.

Lightner received her B.A. in Mathematics and Sociology from UCSD and her M.S. in Applied Mechanics and Engineering. She is licensed by the

State of California as a Professional Mechanical Engineer.

Lightner worked in private industry as an engineer for 23 years. She started her professional career as an Engineering Aide at General Atomics (GA), hired by the High Temperature Gas Cooled Reactor Division after graduation from UCSD. While working full-time at GA, Sherri was certified as an Engineer in Training and took engineering course work. She was quickly promoted to Engineer and then earned an M.S. degree. She worked as an engineer in the Structural Engineering Department at GA for eight years and GA's Fusion Division for another five years. She then accepted a senior engineering position with the Structural Dynamics group at Rohr Industries to work on high velocity (ballistic) impact analysis. After five years at Rohr, she returned to GA to work on the New Production Reactor (NPR).

After another five years at GA working on the NPR and other projects, Lightner retired from the engineering profession and formed with her husband a small technology hardware and software consulting firm in San Diego called Lightner Engineering.

She also took up public service work. She served as a volunteer for several San Diego nonprofit organizations. She was the president of the La Jolla Town Council and La Jolla Shores Association and secretary for the La Jolla Community Planning Association.

In November, 2008, Lightner replaced termed-out San Diego City councilmember Scott Peters.

## February Meeting Details

### The California Budget



**Lori R. Saldaña** is a former member of the California State Assembly from the 76th Assembly district. She served from 2004 to 2010, when term limits prevented her from seeking re-election. She is an announced candidate for the California State Senate in 2012, seeking to succeed the term-limited Christine Kehoe (D–San Diego).

She grew up in the Clairemont area of San Diego, then graduated with a BA in Physical Education and an MA in Education from San Diego State University (SDSU).

Saldaña started her career coaching at Clairemont and Madison high schools and San Diego City College. Later she taught Business Information Technology in the San Diego Community College District and taught Internet-related classes at San Diego State University.

Saldaña was on the founding Board of Directors for San Diego Earth Day and organized the first "Earth Fair" in Balboa Park in 1990. She was chair of the San Diego chapter of the Sierra Club from Jan. 1996 to Aug. 1997 and served in other volunteer positions for the Club. Her main interests were in water reclamation and sewage treatment, especially along the US-Mexico border. She served as Chair of the San Diego Wetlands Advisory Board 1992-94. President Clinton appointed her in 1999 to the Border Environment Cooperation Commission's Advisory Council.

In 2004, after tough grassroots campaigns in the primary and general election, Saldaña was elected to the California State Legislature. She was appointed Assistant Majority Whip and served on the Appropriations, Natural Resources, Veteran's Affairs, and Water, Parks and Wildlife committees. In 2007 Lori Saldaña was named "Legislator of the Year" by Californians Against Waste for her legislation regarding E-waste.

Due to California's term limits, Saldaña's assembly career ended on August 31, 2010 in an acrimonious, late-night session as she pushed legislation banning the open carry of firearms known as AB 1934. Saldaña presented her bill to the Assembly with only 70 minutes remaining in the 2010 regular session, and refused to suspend debate when it became clear that its opponents would not let it come to an early vote. Afterwards, Saldaña lashed-out at fellow Democrats, calling her own party's leaders "disorganized" and described as "embarrassing" their refusal to employ parliamentary procedure tactics to end debate so her measure could be heard. AB 1934 was opposed by virtually all gun rights groups and several civil liberties groups, too, as an unconstitutional infringement on free speech rights.
